2025-2026 PAYMENT PLAN OPTIONS

Annual Full Payment: Due by June 1, 2025 (5% discount)
Semester Payment: Due June 1, 2025, and December 1, 2025 (2% discount)
The 10-month payment plan begins July 2025-April 2026.

FINANCIAL OVERVIEW

Tuition Payment Information

- All-Inclusive Tuition includes curriculum, books, testing materials, the cost of providing electronic devices such as smartboards, Chromebooks, tablets, Ozobots, software programs, security, and device support.

Tuition Discounts

- 5% sibling discount for each sibling enrolled at SOECA
- 15% Word of Faith covenant member (*membership card with your personalized member ID # is required)

Application Fee

- There is a non-refundable application fee of \$125 for the 2025-2026 school year (\$25 discount applied per each additional sibling). This fee includes pre-entry assessments for all grades. The application fee is non-refundable or transferable.

Enrollment & Re-enrollment Fees

- Upon acceptance, the new student matriculation fee in the amount of \$300 is required to reserve your space.
- All current SOECA scholars qualify for a reduced returning scholar matriculation fee in the amount of \$150.

FACTS Tuition Management

- FACTS works with schools across the country to provide tuition management services that make education more affordable. Through the online system, parents pay tuition and fees over time, using a variety of payment methods, thereby making it easier to afford a quality education.
- The online FACTS system allows parents to update their payment methods and view their payment history.

Referral Program

- Enrolled families will receive a \$250 tuition credit once the referred scholar has been enrolled for 90 days with a current FACTS account. The referral family must be enrolled for the 2025-2026 school year to receive the tuition credit. Contact the Admin team to complete the Referral Credit Form.

Financial Aid and Scholarship Information

- SOECA is a partnering school for the Pay it Forward Scholarship Program that provides scholarships for private pre-K through 12th grade scholars to attend any accredited private school in Georgia.
- Their mission is to give parents the freedom to choose the best educational environment for their child.
- Scholars entering either PreK, Kindergarten or 1st grade, scholars who attended a public school for at least one full grading period during the most recent school year, and scholars who received a Georgia tuition tax credit scholarship from any state approved Scholar Scholarship Organization (SSO) in the previous year. In addition, to receive a full scholarship, families must meet the income guidelines for the federal free and reduced lunch program.

Withdrawing from SOECA

We understand that circumstances may arise which necessitate the withdrawal of a scholar from SOECA. Seeds of Excellence obligates itself to contract teachers, staff, and other services based upon enrollment and to ensure the financial stability and planning of our institution, therefore the following policy applies:

- **Notification of Withdrawal:** Parents or guardians must provide written notice of their intent to withdraw their child from the school. This notice should be submitted to the school administration at least 30 days prior to the intended withdrawal date. This policy applies to any withdrawal prior to or during the school year once a Tuition Contract Agreement has been signed and submitted.
- **Tuition Responsibility:** Upon withdrawal, the tuition account will be assessed a \$500 early termination fee (per student) in addition the parents or guardians *are responsible for the full contract tuition amount for the entire school year through May 2026. This policy applies regardless of the withdrawal date. No refunds or prorated tuition will be provided.*
- **Special Circumstances:** Parents or guardians may submit a written appeal to the business office in cases of extraordinary circumstances to the financially responsible parent/guardian, such as relocation due to job transfer, loss of employment, death or severe medical issues. The business office will review the appeal and may, at its discretion, adjust the financial obligation.
- **Payment of Outstanding Fees:** All outstanding fees, including but not limited to tuition and extracurricular activity fees, must be settled before the withdrawal process is considered complete.
- **Records and Transcripts:** The school will release academic records and transcripts only after all financial obligations have been fulfilled.
- **Legal Responsibility:** If SOECA retains an attorney to enforce the Tuition Contract Agreement, then the Responsible Party shall be liable for all of SOECA's costs and attorney's fees (including appellate), any collection expenses incurred regardless of whether or not suit is brought, and reasonable compensation for collection efforts conducted by SOECA's employees or agents.
